

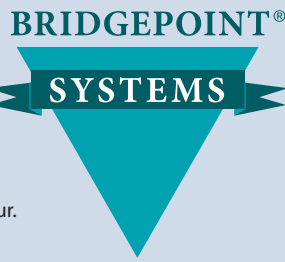


FLEX POWDER WITH CITRUS SOLV

DIRECTIONS:

Pump or Electric Sprayers - Dilute 1 scoop (2 ounces) of Flex Powder with Citrus Solv per gallon of hot water for most soils.

For special case, hard-to-remove or heavy soil, use 2 scoops (4 ounces) of Flex Powder with Citrus Solv per gallon of hot water.

Hydro-Force Injection Sprayer - Dilute 8 scoops (16 ounces) of Flex Powder with Citrus Solv per Hydro-Force 5 quart container of warm water. Dilute at 1 to 8 setting.

Application - Spray on traffic areas of carpet until evenly damp. Allow to dwell for 5-15 minutes. Extract with normal cleaning process.

Booster - Add 1 scoop (2 ounces) to ready-to-use gallon to create General Purpose Degreaser out of any typical prespray.

INSTRUCCIONES:

Diluya 1 cucharada (2 oz) de Flex Powder with Citrus Solv por galón de agua caliente para la mayoría de las manchas.

Para casos especiales, difícil-de-quitar y suciedad pesada, utilice hasta 2 cucharadas (4 onzas) de Flex Powder with Citrus Solv por galón de agua caliente.

Hydro-Force Injection Sprayer: Diluya 8 cucharadas (16 onzas) de Flex Powder with Citrus Solv por 5 cuartos contenedor Hydro-Force de agua caliente. Diluya en una proporción de 1 a 8.

Aplicación: Rocíe sobre las áreas de tráfico de la alfombra hasta que se humedezcan de manera uniforme. Deje que reposen durante 5 a 15 minutos. Extraiga mediante el proceso de limpieza normal.

Intensificador: Añada 1 cucharada (2 onzas) a un galón listo para usar a fin de crear un desengrasante de uso general a partir de cualquier producto de prerociado típico.
